Office Order

Sub: Policy for managing community dogs on campus

The following guidelines are placed to address the growing incidences of dog menace on campus.

- 1. Setting up the following 12 feeding zones on campus:
 - i. Feeding Zone 1- In front of SIDBI Ext.
 - ii. Feeding Zone 2- Left corner of Hall-9 boundary between canal & Hall-5
 - iii. Feeding Zone 3- Near Electric Sub Station-5
 - iv. Feeding Zone 4- Near Solar Plant on Shivli gate road
 - v. Feeding Zone 5- Opposite to main entrance of Hall-5
 - vi. Feeding Zone 6- Between GH Tower Gate and Hall-4 back side
 - vii. Feeding Zone 7- Near SBRA, Health center barrier road
 - viii. Feeding Zone 8- Back side of Lane 37 near pump house
 - ix. Feeding Zone 9- Back side of Lane 35
 - x. Feeding Zone 10- Back side of Lane 32 & 33
 - xi. Feeding Zone 11- Nearly 60 meters from overhead tank towards ACES Ground
 - xii. Feeding Zone 12- Amla Bagiya, Near Type-3 Apartment

There should be no feeding zone inside the academic area.

IWD/DOIP offices shall develop the basic infrastructure with a shed, feeding place and water connection and a foot trail access path at the above designated places.

2. Addressing the food waste and associated litter:

IWD/DoIP offices is advised to develop proper infrastructure for ensuring placing of Caged bins in canteens, vendor shops, stalls, particularly in the academic area, hall of residences, common places such as shopping centers and during any events etc.

3. Sterilization of community dogs:

The Animal Welfare Cell (AWC) is advised to routinely conduct sterilization drives for community dogs on campus.

4. Classifying certain areas as prohibited zones for dog entry:

No dogs shall be permitted in the academic area including lecture hall complexes, rooms and common rooms of halls of residences, conference venues (such as outreach, auditorium and VH area), and children's play areas (such as Park-67 etc.). The security office is advised to implement the above.

5. Guidelines on feeding dogs:

After establishment of feeding zones infrastructure, no feeding shall be permitted in any area outside of these feeding zones. The offenders will be issued a warning. In case of a repeat offence, the offender will be removed from the campus. The security office is instructed to be vigilant and report the violation of dog feeding policy to the Dean of Administration (DoAD) for necessary action.
