Item No. 1: Announcement, if any

There was no announcement.

Item No. 2: Confirmation of the minutes of the 2017-2018/5th & 2017-18/6th meeting held on 27th April, 2018 & 28th May, 2018 in QIP Conference Room (Academic Affairs Building)

Draft minutes of the 2017-2018/5th & 2017-18/6th meeting held on 27th April, 2018 & 28th May, 2018 were circulated amongst the members with a request to give their comments, if any, on the minutes. Since no comments have been received, the minutes were confirmed.

Item No. 3: Consideration of the appeals of those students whose academic programs were terminated at the end of 2017-18-II and earlier semesters due to inadequate academic performance and non-academic reasons

The committee was apprised that as per the recommendations of the Academic Performance Evaluation Committee (APEC) academic programme of 90 students were terminated due to inadequate academic performance or any other reasons at the end of 2017-18-II semester. Out of 90 terminated students, 68 students had submitted their appeals for reinstatement.

Appeals of 68 students were considered by the committee case-to-case basis. After due deliberation on each appeal, based on their academic performance as well as recommendations of the DUGC and Counselling Service, the committee gave its recommendations to the Senate for its further consideration.

Item No. 4: Consideration of the request of Mr. Yashwant Singh (13807813), a BT-MT (Dual Degree) student of MSE department to allow him either to add credit of UGP-3 as DE credit or allow him to shift/swap courses 2nd time.

The committee is apprised that a request has been received from Mr. Yashwant Singh (13807813), of MSE department to allow him to shift/swap the courses between UG and PG Part 2nd time for fulfillment of DE credit requirement in UG part was accepted and recommended to the Senate for its approval.

Item No. 5: Consideration of the requests of the students to allow them to proceed to other institute/university as non-degree students through exchange program for pursuing their course work.
