## Minutes of the 2022-23/2nd meeting of the SUGC held on Friday, October 17, 2022, at 3:30 PM in Room No. 208, Academic Affairs Building, IIT Kanpur

At the outset, the Chairperson, SUGC, welcomed the members present and subsequently, the agenda items were taken up for discussion.

Item No. 1	Consideration of the report of the Core Curriculum Committee (CCC) for 2022-
	23-II regular semester.

The report prepared by the Core Curriculum committee for the forth coming semester (i.e., 2022-23-II) was presented by Dr. Niraj Sinha, Chairman, CCC, before the SUGC for discussion. After due deliberation, some concerns were raised, and it was suggested that some minor corrections have to be made to the CCC report before implementation:

- a. Student's count in the course ESC113 should be corrected in Tables 2.0 and 3.0
- b. Course ELC112 should be removed from Table 1.3
- c. Tutors in the Ethics course must be a faculty member. SUGC has also raised an issue whether as faculty members are well aware and prepared about issues to be discussed in this course. In this connection, Heads should be made aware of proper accounting of teaching load for faculty members participating in the course.
- d. Concern about large numbers of students in a section were raised. It was noted that earlier Institute used to have two tutorials for a core courses. It was then changed to one tutorial and one discussion hour; following that was the IPSA/DIPA model, where problem solving sessions were held with a large number of students and some challenging problems were discussed in the other session. Now number of tutorials/problem solving sessions have come down to only one session, which is pedagogically not encouraging. Some other support system should therefore be developed for these courses where students can have more discussions about the course material.

The committee appreciated the sincere efforts of Dr. Niraj Sinha in preparing the CCC report for 2022-23-II and placed it on the records.

Item No. 2	Discussion	on	graduation	status	of	Mr.	Shubham	Kumar
	(17917686/170686/PHY)							

The committee discussed the graduation status of Mr. Shubham Kumar (17917686/170686/PHY) and looked at the various aspects related to this case and after a long discussion, recommended the following options to student:

- 1. Mr. Shubham can go for BS-MS Dual Degree programme with retraction of his conferred BS degree. If Mr. Shubham opting this option, then he will have to apply for degree retraction first.
- 2. Mr. Shubham can go for two separate degrees BS and M.Sc.-2yr. The courses that he did against his MS requirements could be waived off in the M. Sc.-2yr programme. However, have this is to be done (including the admission) must be decided by the department.
- 3. Mr. Shubham can go for BS degree only in Physics department.

The chairman, SUGC was requested to convey all these points/options to Shubham so that he can take an informed decision.

Item No. 3	Consideration of incomplete registration of the of 17 students who not paid
	fee for current semester (2022-23-I)

The committee discussed the incomplete registration of 16 students (except Mr. Suhas S/190870/CSE\*) due to non-payment of fee for current semester and it has been decided by the committee that these students should be given one last chance to pay fee and if a student fails to pay fee as per given deadline, then their name will be recommended to the Senate for cancellation of registration of current semester.

Students have been advised to deposit fee by October 20, 2022 (Thursday).
