#### Shortlisting Criteria for MSR Admissions – 2024-25, Semester – II

(GN= General, OBC = Other Backward Class, OBC-NCL= OBC-Non Creamy Layer, SC = Scheduled Caste, ST= Scheduled Tribe, EWS= Economically Weaker Section, DAP = Differently Abled Persons)

Candidates are shortlisted for the MSR interviews based on the following criteria:

1. Candidates, who are BTech from IITs (applying without a valid GATE score)
  - a. should have an overall CPI (out of 10) above 6.5
  - b. last 2 years CPI (out of 10) should be above 8.0
2. Candidates, who are BTech from institutes, other than IITs, and applying for full-time MSR
  - a. should have a CPI or normalized marks (out of 10) above the below threshold

- b. should have a valid GATE score, as per <https://www.iitk.ac.in/ee/data/admissions/2024-25/Eligibility-Criteria2.pdf>,
3. Candidates with BTech applying for part-time/ sponsored/ external (defined at <https://tinyurl.com/yuwwy3hs>) MSR
    - a. should have a CPI or normalized marks (out of 10) above the below threshold

- b. The sponsoring organization must specifically undertake to provide full salary to the candidate and to relieve him/ her to pursue the program as specified in PG manual. The candidate must show a signed letter in this regard at the time of interview.

Please keep checking <http://www.iitk.ac.in/ee/admissions> and your emails for updates and relevant announcements. The interviews will be held on May 29, 2024 in a hybrid mode. . The shortlisted candidates will be given an option to choose the mode of interview.

**Note:** A candidate, who satisfies the above criteria, may still not be present in the list of shortlisted candidates for any of the following reasons:

1. Candidate has not applied for the stream she/ he is eligible for (see <https://www.iitk.ac.in/ee/data/admissions/2024-25/Eligibility-Criteria2.pdf>).
2. GATE discipline of the candidate makes him/her ineligible for the stream(s) she/he has applied in case GATE score is required. Details are mentioned at <http://www.iitk.ac.in/ee/admissions>.
3. The stream was not the first preference (refer to announcement dated Oct 22, 2024 at <https://www.iitk.ac.in/ee/admissions>).
4. The work experience requirement, wherever applicable, is not met as per <https://iitk.ac.in/doaa/pgadmission/important-links.php>.
5. Application might have been incomplete, or fees may not be paid.
