- 1.Bidders shall quote only those products in the bid which are not obsolete in the market and has at least 2 years residual market life i.e. the offered product shall not be declared end-of-life by the OEM before this period.
- 2.Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.
- 3.Experience Criteria: The Bidder or its OEM {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU / Public Listed Company for 3 years before the bid opening date. Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the year. In case of bunch bids, the primary product having highest value should meet this criterion.

Warranty period of the supplied products shall be 1 years from the date of final acceptance of goods or after completion of installation, commissioning & testing of goods (if included in the scope of supply), at consignee location. OEM Warranty certificates must be submitted by Successful Bidder at the time of delivery of Goods. The seller should guarantee the rectification of goods in case of any break down during the guarantee period. Seller should have well established Installation, Commissioning, Training, Troubleshooting and Maintenance Service group in INDIA for attending the after sales service. Details of Service Centres near consignee destinations are to be uploaded along with the bid.
- 20.NET WORTH: Net Worth of the OEM should be positive as per the last audited financial statement.
- 21. Buyer Added text based ATC clauses
 - 1. The delivery period should be specifically stated.
 - 2. Quotations should not be an exact copy of the specifications mentioned above.
 - 3. Along with the technical comparison, the manufacturer's specification sheets for the product must be enclosed

- 4. The acceptance of the above item shall be done after the testing the SPCM (Single Photon Counting Module) site at IIT Kanpur.
- 5. Technical data sheet and Compliance sheet of the quoted item must be provided with the quotation.
- 6. The bidder shall be the original manufacturer or authorized dealer/ representative of original manufacturer. The authorized representative shall provide a certificate of authorization from the manufacturer.
- 7. The bidder/OEM shall provide at least 2 number of user references with contact details where she/he has supplied the similar system within India in the last 3 years.
- 8. The product should be offered with minimum one year warranty.
- 9. Maximum educational discounts should be applied this equipment will be used in a laboratory that will support research as well as teach and train students.

Disclaimer
