- The hardware vendor should be a reputed concern, having a global presence in multiple countries. The vendor should have ISO certifications.
- OEM should provide serviceable dust filter for avoid workstation failures due to dust and it should be connected into the workstation
- Window OS and Linux Certification, EPEAT Gold India Registered, Energy Star, WEEE, Leading ISV's
- OEM should have a global presence & Top 3 WS OEM certified by IDC or Gartner.
- The bidder should be either OEM or his authorized dealer/distributor having its registered office in Kanpur to provide sales and 24x7 support.
- The bidder should submit case specific Manufacturer's Authorization Certificate along with the bid for each of the products quoted. Bids not accompanied by valid OEM MAC shall be rejected.
