1. Dell PowerEdge R230 Rack Server Intel Xeon processor E3-1200 v5 product family (one), No operating system, Intel C236 chipset, 8 GB RAM DDR4 DIMM, 2.5" 7.2k HDD in RAID 10 (1 TB storage), Broadcom quad-port 1Gb Base-T adapter with BCM5720 network controller, 250W PSU, 1U chassis

2. Branded 2kVA UPS *with* protective frame (completely covering the UPS with a meshed/wired frame).

The closing date for the above item is <u>5 pm on Jan. 25, 2016</u>. The prospective suppliers are required to <u>send quotation in sealed envelopes</u>.

A single **Technical and Financial Bid** must (i) contain detailed technical specification of the product being offered (with model number and make/brand) and (ii) include the detailed price quotation clearly <u>including the cost of the equipment</u> (with model number and make/brand name), taxes, service charges if any, shipping and handling charges. This should also mention the guarantee and complete spare parts must be included that are required for functioning of the unit.

Terms and Conditions:

- 1. Maximum educational discount, if any should be offered
- 2. Validity of quotation should be at least for 60 days
- 3. Prices should be on CIF and FOB separately (if imported)
- 4. Prices should include the installation and training cost
- 5. Warranty should be for at least two years after installation
- 6. Normal payment terms for the Institute will be applicable (70%-30% or 90%-10% on delivery of the remaining after satisfactory installation/inspection)
- 7. Quotation should carry proper agency certificate, proprietary certificate, etc.
- 8. An undertaking that the vendor will supply all the spares and services for the equipment for at least 5 years from the date of commissioning
- 9. Delivery must be within 3 months
