Quotation is sought for service contract (SC) for a Selective Laser Melting (SLM) machine installed at Mechanical Engineering Department, Indian Institute of Technology Kanpur. The make and model of the SLM machine is Concept Laser - GE Additive MLab cusing 100R (w/ Two Build Modules 90x90 (One Additional Reactive Build Module) + Standard Build Plate). The SC sought is tentatively for 4 years.

Terms and Conditions:

- 1. Maximum possible educational institute discount should be offered.
- 2. Remote Troubleshooting and Diagnosis: Response within 4 hours
- 3. On-site service: In case repair of machine is required at the installation site, the response should be within 7 days of request. The service should include all Parts required for repair along with Shipping of such parts. The lead time to reach the spare parts, if required for repair, at the site should be within 6 weeks. The service engineer's travel, boarding and lodging cost will not be borne by the customer. This on-site service should be provided every time any on-site repair is required. In other words, there will be no upper limit on this service in a year.
- 4. Preventive Maintenance (PM): At least 1 per year over the life of the contract (to be provided within 30 days of request). The standard maintenance for PM should include:
 - Replace wear parts. Labor and shipping included.
 - O2 sensor calibration verification.
 - Clean interior and exterior surfaces of Process Chamber and Glove Box.
 - Inspection of Concept Laser GE Additive supplied accessories.
 - Inspect, adjust and clean optical items such as F-theta lens, laser protection glass, etc. This shall also include focus height verification.
 - Verify laser power calibration and adjust linearization as required.
 - Laser cooling system inspection and fluid change.
 - Generate and archive any necessary back-up files.

- Provide service and calibration data
- 5. The service provider should provide all machine software upgrades (CL WRX Software suite, Autofab, and any other software as required).
- 6. The service provider should produce the certificate from the original equipment manufacturer (Concept Laser GE Additive) stating that the provider is authorized to provide the services and maintenance for this particular SLM machine.
- 7. Validity of quotation should be at least for 30 days.
