Sealed quotations are invited from reputed, experienced and financially sound Companies/Firms/Agencies for award of Annual Rate Contract for supply of High Purity gases, new empty cylinders, regulators, valves etc. (list enclosed). The quotation should reach this office by 3.30pm on 14.09.2017 (Thursday).

- 1. The quotations should be submitted in the enclosed format duly signed, stamped & sealed in an envelope addressed to the Jt. Registrar, Stores & Purchase Section, Indian Institute of Technology, Kanpur-208016 invariably mentioning reference of enquiry on the envelope.
- 2. Firms should give separate quote for each article.
- 3. The rates offered should be Ex-Warehouse in case of firms situated outside Kanpur and free delivery at the Institute premises in case of local firm. Transportation charges should be mentioned separately, as indicated in Annexure 'A', if applicable.
- 4. The rates offered should be exclusive of GST.
- 5. The delivery period should be specifically stated.
- 6. The quotation should have a validity of at least 1 year.
- 7. The rates quoted should be in metric units (in case of refilling of cylinder(s), otherwise your quotation is liable to be rejected.
- 8. The right to reject all or any of the quotations and to split up the requirements or relax any of or all of the above conditions without assigning any reason is reserved with the institute.
- 9. The Institute will provide empty cylinders to the appointed firm who will in turn provide back the refilled cylinders to the institute.

- 10. Purity Certificate for gas and Test certificate for cylinder (from Explosive department, Nagpur) must be provided alongwith new cylinders.
- 11. The supplier should enclose manufacturing certificate in case of manufacturer or authorization of manufacturer in case of dealer.
- 12. Bidder should have minimum turnover of not less than **20 Lacs** per annum (enclose details).
- 13. The tenderers should have completed satisfactorily at least 3 similar works, (out of three, one should be in Central Govt./Autonomous bodies/Hotels/Educational Institutions/Universities.)
- 14. The List of the customers (with their full address) where similar nature of services were rendered during the last three years i.e. 2014-15, 2015-16 & 2016-17 from 1st April to 31st March.
- 15. Copy of the satisfactory work completion certificate for three similar work in any Government Department / Autonomous bodies /Educational Institutions/Universities.
- 16. The firm should not have been blacklisted by IIT Kanpur or any other department/Institution in the past. Also, there should not be any major issue in terms of supply of gases/safety issues/purity issues etc. Kindly submit declaration for the same.
