9. Installation of an electric pole in Jhula Park.


10. Provision of Wi-Fi in SBRA.

12. Revision of fines for not vacating SBRA during academic leave or semester leave.


The agenda was re-discussed and slight changes were made to the rule. As per the new rule: If any resident is unregistered, he/she has to vacate the house immediately. In special cases, a request for an extension can be made. The request should be submitted in the form of a letter to the Warden, SBRA, through the convener every month. Permission shall be granted only after the signature of the Warden, SBRA. If someone is found living in SBRA unregistered without permission, an additional fine of Rs. 6000 per month will be imposed on him/her. The fine for the extension period will be as follows:

Time period after	Fine
First Month	No fine + standard rent
Second Month	Rs. 2,000/ + standard rent
Third Month	Rs. 2,500/ + standard rent
Fourth Month	Rs. 3,000/ + standard rent
Onwards	Rs. 12,000/ + standard rent
